

THIRD SUPPLEMENTAL AMENDMENT

DECLARATION OF CONDOMINIUM OWNERSHIP

This is a Third Supplemental Amendment to the Declaration of Condominium of Homestead at Highland Lakes Condominium is made on or as of the 7<sup>th</sup> day of July, 2005.

**Recitals**

A. Homestead at Highland Lakes Condominium is a condominium created pursuant to the provisions of Chapter 5311 of the Revised Code of Ohio ("the Condominium Act") by the filing of the Declaration of Homestead at Highland Lakes Condominium Official Record Volume 189, pages 1504-1547, and Plat Cabinet 2, Slide 715, et seq., both of the records of the Recorder of Delaware County, Ohio, and all amendments thereto.

B. At the request of Homestead Highland Lakes, LLC., "the Declarant", Unit owners exercising not less than seventy-five percent (75%) of the voting power of Unit owners in the Condominium, approve and consent to this amendment, which permits the one time construction and addition of a new type of Unit in the Condominium. This unit shall be referred to as Unit 5516-34.

C. Pursuant to the provision of Article XIX, Section 1 of the Declaration, and Chapter 5311 of the Revised Code of Ohio, the Declaration may be amended in the respects modified and amended hereby with the consent of Unit owners exercising not less than seventy-five (75%) of the voting power of Unit owners and the consent of eligible holders of first mortgages on Units to which at least fifty-one percent (51%) of the votes of Units subject to mortgages held by eligible holders of first mortgages appertain has been obtained.



D. Unit owners exercising seventy-five percent (75%) or more of the voting power of Unit owners, duly approved and consented to the adoption of this Third Supplemental Amendment to the Declaration. There are no eligible holders of first mortgages on Units and so no such consents are necessary.

E. These amendments to the Declaration, do not, in any way, enlarge, diminish, or change the size, location, composition, scope or extent of any existing Unit, nor the Unit designation of any existing Unit.
